SUPERINTENDENT EFFINGER TOLD THE PARK CORPORATION MEMBERS HEATHER HALL HAD CONTACTED HIM THIS MORNING AND SHE WAS HOME SICK. HEATHER TOLD HIM SHE WOULD BE AT THE MARCH MEETING.

MICHAEL MANIS TOLD THE PARK CORPORATION MEMBERS HE HAS NOT HEARD ANYTHING AT THIS TIME FROM MR. DUMAS ON WHEN THE FUNDRAISING WILL BE STARTING. MICHAEL TOLD CORPORATION MEMBERS HE WILL LET EVERYONE KNOW AS SOON AS HE HEARS SOMETHING. A LENGHTY DISCUSSION FOLLOWED.

MASON. MOTION CARRIED.

SUPERINTENDENT EFFINGER PRESENTED MEMBERS WITH THE IDEA OF PUTTING CEILINGS IN THE ZORICH, HALL AND GIFFORD SHELTERS, PLUS THE GIFFORD SHELTER IS IN NEED OF A ROOF AND THE PLAYGROUNDSW ARE IN NEED OF MORE MULCH. A BRIEF DISCUSSION FOLLOWED.
