A. The Applicant is hereby notified of the following conditions:

1. That all rules, stipulations and Ordinances of the City shall be adhered to.
2. That the applicant's property is within service distance of a natural gas main, as defined by Ordinance.
3. That the City is under no obligation to install the service line and facilities until such time as the applicant shall give assurance that gas will be used within 60 days
4. That with the filing of the "Application for Gas Service" the City will reserve such funds and facilities to install service to the applicant without delay upon proper request.

B. In consideration of the above, the applicant agrees as follows:

1. To grant an easement over said premises in favor of the City of Rensselaer, for the purpose of laying, maintaining, metering, repairing and replacing the natural gas line servicing my premises or the adjoining premises.
2. It is understood and agreed that the company is under no obligation, nor can it be held liable for any damages for not serving my premises, until such time that the gas distribution mains have been installed and gas is available for general use for the area where my property is located.
3. To file an "Gas Equipment Application" with the company, for the installation of any gas equipment and not to use such equipment until it has been inspected by the City Gas Superintendent.
4. That the City assumes no responsibility for the interruption of service and the City shall have the right to discontinue to my property for any of the reasons prescribed by Ordinance.
