STACE TOLD MEMBERS HE MIGHT BE LOOKING TO SEE IF IT COULD BE USED FOR MISCELLANOUS THINGS FOR THE NEW BASEBALL FIELDS. STACE TOLD CORPORATION MEMBERS THE NEW BASEBALL FIELDS ARE CURRENTLY BEING REBIDDED. A BRIEF DISCUSSION FOLLOWED.

SUPERINTENDENT EFFINGR DISCUSSED WITH CORPORATION MEMBERS ABOUT NAMING THE SMALL SHELTER BY THE POOL THE JIMMY MCFALL MEMORIAL SHELTER. SUPERINTENDENT EFFINGER TOLD CORPORATION MEMBERS JIMMY MCFALL WAS THE YOUNG MAN THAT DROWN IN THE PIT YEARS AGO AND OUR COMMUNITY WORKED TO GET THE LARUE MEMORIAL POOL SO PEOPLE HAD A PLACE TO SWIM. SUPERINTENDENT EFFINGER TOLD PARK CORPORATION CURRENTLY THE SHELTER HAS NO NAME AND THIS WOULD BE THE PERFECT TIME TO NAME IT. A BRIEF DISDUSSION FOLLOWED.

AFTER THE DISCUSSION A MOTION WAS MADE BY KEVIN ARMOLD AND THE MOTION WAS SECONDED BY SCOTT BARTON TO NAME THE SMALL SHELTER BY THE POOL THE JIMMY MCFALL MEMORIAL SHELTER. MOTION CARRIED.
