A MOTION WAS MADE BY JENNY BOGET AND SECONDED BY STACE PICKERING TO ACCEPT THE TREASURERS REPORT. MOTION CARRIED.

ZION MILLER & REIN BONTRIGER CAME TO THE PARK CORPORATION ABOUT PAINTING A MURAL ON THE POOL BATHHOUSE. ZION TOLD THE PARK CORPORATION MEMBERS THERE IS \$2,500.00 ALREADY FOR REIN TO PAINT A MURAL ON A PORTION OF THE BATHHOUSE AND THEY WOULD LIKE TO DO THE COMPLETE MURAL. ZION ASKED THE PARK CORPORATION MEMBERS IF THEY COULD MATCH THE \$2,500.00 ALREADY COMMITTED TO THE MURAL SO REIN COULD DO THE ENTIRE MURAL. REIN PRESENTED A COPY OF WHAT THE MURAL WOULD LOOK LIKE AFTER COMPLETED. REIN HAD ONLY REQUEST IF THE PARK WORKERS COULD PRESSURE WASH THE NORTH & WEST SIDE OF THE BUILDING SO RYAN PRESTON COULD PRIME THE 2 SIDES. A DISCUSSION FOLLOWED.

MICHAEL MANIS DISCUSSED WITH PARK CORPORATION MEMBERS THE STATUS OF FILSON PARK. STACE TOLD MEMBERS THEY ARE WAITING ON TITAN CONSTRUCTION FOR THE NECESSARY DRAWINGS SO THE STATE PERMIT CAN BE FILED. A DISCUSSION FOLLOWED.

AFTER THE DISCUSSION, A MOTION WAS MADE BY JANICE DENO & SECONDED BY STACE PICKERING TO GET THE APPLICATION FILED AFTER TITAN CONSTRUCTION FINISHES AND HAVE SUPERINTENDENT EFFINGER SIGN THE STATE PERMIT WHEN IT IS READY TO BE FILED. MOTION CARRIED.

THE RIBBON CUTTING WILL BE HELD AT NOON BY THE SIGN AT THE BASKETBALL COURT LOCATED AT THE SOUTH END OF BROOKSIDE PARK.

STACE PICKERING TOLD PARK CORPORATION MEMBERS THEY WILL HAVE A RECOMMENDATION FOR PARK CORPORATION MEMBERS ON THE PARK & LEISURE DIRECTOR'S REQUEST AT OUR NEXT MEETING. THE COMMITTEE WILL BE MEETING ON JULY 26TH AT 3PM AT CI INSURANCE OFFICE TO DISCUSS IT. A BRIEF DISCUSSION FOLLOWED.

STACE PICKERING ASKED SUPERINTENDENT EFFINGER IF HE WOULD PLEASE ADD THE NEW PLANTS AT THE DAVID DAY SIGN TO THEIR WATERING LIST. SUPERINTENDENT EFFINGER TOLD CORPORATION MEMBERS, HE HAD ALREADY ADDED IT TO THEIR LIST.
